All applicants will be considered for FREE admission on a first-come, first-served basis and may be eligible for the following WIP showings: June 17, September 23 or the Winter Gala (date TBA).

The WIP Series presents in studio showing of works in progress and culminates in an annual showing of finished works. This series is designed to provide a venue for both emerging and professional choreographers who are working in the area of contemporary and experimental choreography and is open to all artists working in this vein in both the province of Saskatchewan and across Canada. Audience members play a pivotal role to the choreographers by providing valuable feedback that are instrumental to the further development of their works.

7. Upon confirmation, complimentary tickets will be held at the door under your individual name or group name and can be claimed on the date of the performance that you have been awarded tickets for.
8. Valid government issued photo identification is required to be shown to redeem ticket.
9. Free Flow Dance Theatre Company reserves the right to deny an application based on false or misleading information.
10. Low income tickets are non-transferable.
